

**TOWN POLICE CLAUSES ACT 1847**  
**EREWASH BOROUGH COUNCIL (WILNE 10K)**  
**(TEMPORARY CLOSURE) ORDER 2021**

**WHEREAS** EREWASH BOROUGH COUNCIL (hereinafter referred to as "the Council") are satisfied that vehicular traffic in parts of the Borough of Erewash should be restricted by reason of the holding of the Wilne 10K Road Race.

**NOW THEREFORE** the Council in exercise of its powers under Section 21 of the Town Police Clauses Act 1847 and of all other powers enabling them in that behalf hereby make the following Order:

1. On the fifth day of September two thousand and twenty-one no person shall cause or permit any vehicle other than a vehicle connected with the emergency services to proceed in the lengths of the roads specified in the Schedule to this Order between the hours of 8.00 am and 12.00 noon except on the direction or with the permission of a police officer in uniform.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. This Order shall come into operation on the fifth day of September two thousand and twenty-one and may be cited as the Erewash Borough Council (Wilne 10K) (Temporary Closure) Order 2021.
